#### **Highlights for Q1FY18**

- **Revenue from Operations** is at Rs 1,526 lakh
- **EBITDA up 9.4% to Rs. 277 lakh** as compared to Rs. 253 lakh in Q1FY17
- **EBITDA Margins** have improved by 160 bps to 18.2% as compared to 16.6% in Q1FY17
- **Profit after Tax up 7.4% to Rs. 96 lakh** as compared to Rs. 90 lakh in Q1FY17
- **PAT Margins** have improved by 40 bps to 6.3% as compared to 5.9% in Q1FY17

*Commenting on the results and performance, **Mr. Narayan Saboo**, Chairman said:*

*“It gives me immense pleasure to share with you the our Q1FY18 Results. Our company has achieved a **Revenue of Rs. 1,526 Lakhs, EBITDA of Rs. 277 Lakhs and PAT of Rs. 96 Lakhs**. We have been able to improve our **EBITDA Margins by 160 basis points to 18.2%**. Our **PAT Margins have also increased to 6.3%**.*

*We witnessed the rollout of India’s groundbreaking fiscal reform i.e. GST which will transform India into a single marketplace. This is good news for organized players like us. The Government in its efforts to preserve the environment has taxed AAC (Autoclaved Aerated Concrete) at 12% which is significantly lower than the earlier tax regime. Traditional red bricks which were earlier not taxable are now taxed at 5%. This shall greatly benefit us in the coming future*

*Also, with the government having high focus on Infrastructure Development and Housing for All, we expect the demand for AAC Blocks to increase multi-fold in the future.*

*In view of long term sustainability of our business, we are planning to expand our Capacities from 3,00,000 cubic metres per annum to 9,00,000 cubic metres per annum.*
